1. Both Conformance Testing and Functionality Testing were completed based on Airwave Generic Conformance Test Specification and Omniguard Acceptance Test Specification Phase 1A document P0914D10/1B dated 09/10/09.
2. During the testing number of observations were recorded which will be actioned in accordance observation tracking report. However, one such observation is below and customer should be informed of the impact as appropriate.
 - Action buttons on the Monitor screen can be sporadic under load (i.e. acknowledge & clearing Emergencies, etc). This button sometimes requires pressing twice to acknowledge request activated by Omniguard application. **This will be resolved before end Jan 2010.**
