The testing conducted on the Equipment suggests that it will not adversely impact the Airwave Network (as it had been configured in accordance with the above specifications). The testing was conducted to meet the requirements for Conformance and generic functionality in accordance with the specification.

## **Observation/Comments:**

- 1. Both Conformance Testing and Functionality Testing has completed based on Airwave Data Conformance Test Specification v4.
- 2. When the device is "Stun/Kill" by the network command, no messages can be transmitted or received by device, however, any messages that are already on the device can be viewed. It is therefore recommended that TDM is not used for any classified data.
