The concession review conducted on the Equipment suggests that it will not adversely impact the Airwave Network (as configured in accordance with the above specifications) when connected and used. The review was limited to Conformance tests in accordance with the latest applicable specification and hence no specific functionality or performance of the product was considered unless specified below or in the test results.

## **Key Observation/Comments:**

- The initial Conformance testing was conducted on 15/05/2019 on SEED MTA v 1.0.0.6 and BRIGID MDT2 v2.0.2.0 and then subject to a concession following changes to the software as listed in Seed Software Short Data Router MTA Release Notes dated 5/10/2020 for SEED MTA up to v1.0.4.1 and MDT2 Release Notes dated 10/09/2020 for BRIGID MDT2 up to v2.1.9.0. This concession supplements the original certificate following changes to the software as defined in Lampada Gateway Release Notes Bug Fix item for SDS MTA 1.0.4.3 dated 15/09/21
- 2. No further conformance testing has been carried out and this Concession Certificate has been issued purely on the assessment of the submitted documents and declaration by Telent.
- 3. Key changes in the release Log issue fix and code quality improvement.
