The testing conducted on the Equipment suggests that it will not adversely impact the Airwave Network when connected and used (as it had been configured and tested during certification in accordance with the above specifications). Test scope was limited to conformance tests in accordance with the latest applicable specification and hence no specific functionality or performance of the product was tested unless specified below or in the test results.

Key Observation/Comments:

- 1. Live FOA trial successful from 24/03/2014 to 22/04/2014.
- 2. Summary of FOA trial in a Live Control Room captured in ADP document titled 'IS395 Windows 7 Customer Trial Review'.
 - a. No reported issues over trial period.
 - b. CPU usage captured. Shows improvement on Windows 7 versus Windows XP
 - c. Memory usage
- 3. Certificate re-issued 24/10/16 as a result of Reference System testing against R7.1.2, when the following behaviour was noted: -

When an operator position shuts down or restarts whilst in an on-going private call, any attempt to initiate a private call upon recovery will fail.

- a. Inbound and outbound private call attempts are affected.
- b. Requires restart of the impacted operator position and CCI Port to restore private call capability to the position.
